- NRI fee is applicable for the full duration of the course for candidates who have pursued and completed their last qualifying exam from outside India and for candidates who have applied under NRI Category.
- All students are required to pay a refundable caution deposit of ₹10,000 along with the first installment of tuition fees.
- All students are required to pay ₹3,000 towards the membership of Alliance Alumni Association ₹1,500 towards the convocation fees along with the first installment of tuition fees.
- Students are advised to pay fees above ₹10,000 via RTGS/ NEFT/Online/ DD.
